AGM 2020 Online by Jim McIntosh

For the first time ever the Party held its Annual General Meeting on Zoom. One advantage is no need to travel in order to participate. The meeting went quite well and 24 people registered.

Leader Keith Komar reported that the government response to the Corona Virus has given the Party lots of opportunities to protest and find new members. We need our members to get active in their communities. He also recommended the Libertarian Leadership Academy for prospective election candidates.

Chairman Matt Dougherty reported we now have 5 CAs across the province and plan to create more. He also provided tips for collecting signatures in rural and urban ridings for those who are considering running as candidates for the Party in 2022.

Treasurer Andrew Allison reported we have had relative financial success in spite of COVID-19 and saw big increases as a result of lockdown protests. Over 100 donors, many of them monthly, have contributed over \$7000 to date. We have also received In Kind donations, including Bond Keevil's updates to our web site.

Guest Speaker Elizabeth Marshall is a Director of Research at the Ontario Landowners Association and Author of Property Rights 101. She talked about how our property rights have been eroded over the last 50-60 years, in part because we don't understand them. Property Rights in Canada are protected by preconstitutional law but our politicians ignore that fact. The Auditor General is supposed to ensure none of our laws violate those rights. Law schools are not teaching about the Constitution and our rights, especially Property Rights.

It's Time to Change Social Media Platforms — By Bond Keevil



Many of our supporters have responded to the current deplatforming trend by using Facebook and Twitter less, and using their competitor platforms more. The Ontario Libertarian Party has created accounts on several new social media platforms to meet this demand.

Freedom of speech laws apply to government, not private companies. Nobody should ever be forced to do business with someone they disagree with. But extensive government collusion with big tech companies have caused the lines to be blurred as to whether a big tech company can qualify as being considered privately owned; they clearly are not privately controlled.

The libertarian political solution to the problem of big tech censorship is to end this collusion between the state and tech companies. The Ontario Libertarian Party would cut all corporate welfare and subsidies handed out to tech companies by the province, creating a level playing field for all competitors. We would also put an end to the regulation of Ontario media outlets and Internet companies. These political actions would restore competition and ensure that all tech companies are held

accountable to market forces rather than political control.

We can ban big tech from our own lives just as easily as they have banned the information they disagree with. There is a vast supply of information on the Internet that is compatible with our values and principles and people will not stop producing such information just because a few companies disagree with them. We can use competitor platforms more and big tech platforms less.

AGM—Amendments to the Constitution

Our second Guest Speaker was Tony D'Orasio, 1st Vice-Chair and former Chairman at the Libertarian Party of New York (LPNY). He told us about a recent meeting he attended with a number of gym owners in a gym in Orchard Park, a suburb of Buffalo. The Erie County Sheriff and an official from the Health Department arrived to shut them down but were shouted out of the club. The LPNY were better organized when the Governor decreed no more than 10 people in your house for Thanksgiving. They sent letters to all 62 county Sheriff's offices asking them not to enforce this Executive Order. 60 replied they agreed, even the NYPD. They issued Press Releases which garnered publicity in the smaller towns. His parting message was, "Don't try to do it all yourself." Prepare plans and organize volunteers.

After a lunch break we elected members to fill positions of Deputy Leader (Jacques Boudreau), Recording Secretary (Jim McIntosh), two Members at Large (Jeff Everingham and Dan Little) and two members of the Ethics Committee (Jean-Serge Brisson and Gerry Bourdeau). Keith provided an online polling mechanism so Delegates could vote secretly from home. See election results on page 4.

Amendments to the Constitution

The first dealt with Article 4 - Membership and Associate Status. The proposed amendment was to provide for a free membership which would not have any voting or other privileges of full Membership. This is something the major parties do prior to Leadership conventions. There was considerable debate. The Delegates finally approved the following amendment.

"To add a third level of membership to the membership types. This will be a free membership option for individuals. A free membership is for one year and would allow access to members only sections of the web site. Those on a free membership will be given no voting privileges or any other such perk that paid members in good standing receive. To clarify, a free member is not allowed to attend convention unless they pay the membership fee on the spot, not allowed to serve on the board of the party or the board of a Constituency Association (CA), cannot provide input or vote on platform de-

velopment, cannot seek nomination as a candidate, and cannot vote to confirm a candidate at the CA level. This removes any and all risk of a party takeover by free members"

How this will actually be implemented is yet to be determined.

The second amendment dealt with Article 9 – Caucus. We agreed to amend item 1 re Standing Candidates to include all remaining members of the Executive Committee in the Caucus (i.e. in addition to the Leader and Deputy Leader, if they ae not already Standing Candidates). We also agreed to amend item 2 d. to "the Member who has run in the most recent provincial election, as long as membership is current, they are in good standing with the party, and they have completed all candidate obligations to Elections Ontario. Jim who was CFO for all 116 Libertarian candidates in the 2018 General Election reported that Elections Ontario had reported him and 7 of our candidates who had not submitted their signed and audited Financial Statements to the Attorney General for possible charges and fines.

There was time for questions from the floor. One attendee was concerned that our Statement of Principles states the government is responsible for the courts, and this could put them above the law. Jim explained that the only control the government has is to appoint a Judge to the court, and cannot replace them unless they have committed a (serious) crime.

Jim asked what the objective of the 2022 election would be. Should we try for more votes or more members? If the former, then we should be 'moderate' as in 2018 when we offered alternatives to the government monopolies instead of abolishing them. Or we could be 'radical' like Ron Paul during his quest for the Republican Presidential nomination. We got many new members thanks to him. Coreen advised we need to think about the political landscape for the next election (Freedom Party, Trillium Party, the New Blue Party). We need to be more radical to distinguish ourselves, rather than get lost in the shuffle by being moderate. She hesitates to say "radical" because most people aren't radical. It was agreed this needs more discussion, which is happening at our regular platform planning meetings.
